3 Ensure all employees have their SIN and the correct home address on their Employee Profile. [Read more >](#)

5 Review tax slip groups for the 2023 tax year. Insert, modify, and delete as required. [Read more >](#)



Tip: If you have processed year-end in Avanti in a prior year, there is an option to copy last year's tax slip groups. If you have created any new pay groups or 2023 was your first year processing tax slips in Avanti, you will need to insert new tax slip groups.

6 Extract employee tax slip data for 2023. [Read more >](#)



Tip: Select 'extract from history' when extracting employee tax slip data, unless otherwise directed by your implementation specialist.

7 Import external tax slip data for adjustments or employees from an external source if applicable. [Read more >](#)

9 Review and modify your employees' extracted and imported tax slip data. [Read more >](#)

10 Validate the tax slip groups to prepare for review listings. [Read more >](#)

- 13** If you have employees in Quebec, print the RL-1 summary and update any remaining required fields. [Read more >](#)
